Cassidy has always loved music. Her mom has a video of her at age six, performing to the songs of “Charlie and the Chocolate Factory.” But now, Cassidy and Noble Music Therapist Drew Davenport are turning the cartoons she draws into lyrics. To the tune of songs like “Crocodile Rock” by Elton John, Cassidy is using music to learn how to cope with life’s challenges. Each song features a character named Little Mac facing a situation that Cassidy has had to deal with in school. By the end of the song, Little Mac has discovered a solution—and so has Cassidy. Noble’s music therapy has

been a wonderful creative outlet for Cassidy. It gives her a chance to express herself in a whole new way. Drew helps her write her very own songs, and then they perform them together. They even record themselves so Cassidy can listen to them again later.

Although it is sometimes difficult for Cassidy to do what Drew is asking her to, he finds a way to help her make things happen. And that’s the sweetest music of all.*

Quinn's dream was to learn how to ice skate, so when he took that first hesitant step onto the ice at Arctic Zone in Westfield, playing hockey was not on his mind. Just 23 minutes later, however, the 10-year-old had ditched the red plastic skate support and was gliding by as his dad videotaped the whole thing. Now Quinn confidently practices his slap shot every Sunday evening, as his four-year-old sister cheers him on. Quinn's mom Colleen learned about the Indy Twisters when owner Steve Tofaute presented at one of Noble's Central

Indiana Autism Support Group meetings. "This has been great for Quinn. We've tried other activities, but now it's all hockey, thanks to Noble." says Colleen. Quinn agrees. After he dons his pads and helmet and laces up his skates he is ready to get down to business. He notes proudly, "I have always dreamed of ice skating, and the hockey team gives me the support I need to do it myself."
